It had been my hope and expectation that we should be able to keep the record clear of what follows; but David Haar would not have it so.

For a serious breach of discipline involving the plighted word of honor on part of a group of fellows who by special permission of Mr. Haar overstaid their village furl as limited by the Director -- the Senior Camp was ordered closed after breakfast Aug. 9, with the proviso that any fellows who desired to make arrangements for the continuance of their visit on the Alliance farm might confer with the Director to that end.

With this suggestion the boys promptly complied first by sending a delegated committee of inquiry and then by coming in a body to "take their medicine like little men". Meantime, however, David Haar had walked off into space in open rebellion and contempt of authority.

The Camp having been reopened -- its commissariat in charge of Mr. Berk, its order and discipline under control of J.A. Levy, president-elect of the Camp Society, as reported in last week's

issue of the NEWS--our first concern was, if possible, to rehabilitate David Haar as Superintendent; for it was assumed that rash impulse and not reasoned intent had prompted him to desert his post. The following letter, bearing the Director's O. K. and signed by President Levy, Vice president Saperstein and Secretary-Treasurer Drogin, was accordingly dispatched without delay:

Dear Mr. Haar:

We thank you heartily for the good times, wholesome advice and sound training you gave us as president of our Society and superintendent of the camp. We regret, therefore, that you saw fit to leave us, especially in the manner you did.

Having reorganized with the advice of Dr. Krackowizer under management of the undersigned as executive committee; the Camp having reopened in full accord with the supreme authority of the Director, and Mr. Berk having assumed charge of commissariat and bathing--by unanimous vote upon motion of Dr. Krackowizer we request you to return without prejudice and to resume the active direction of our Camp and Society.

Forty eight hours after his departure Mr. Haar returned, but seemingly unreconciled to the status quo, which while necessarily maintained as a matter of wholesome discipline and unquestioning authority, the Director sought in every way feasible so to mitigate as to safeguard Mr. Haar's proper self-respect and to re-establish his
